It's that time of year again! Shades Cliff Pool will soon be opening for the season. **Opening day is Friday, May 22nd!**

Member Profile. Please visit shadescliffpool.com to update your account (family level) and individual member profiles. Please be sure to check carefully all data transferred from the old system as that process was very manual.

A member is defined as the stock certificate holder, his or her spouse or domestic partner, and any unmarried, dependent children 25 years old and younger of your immediate family who reside within the home. In fairness to all members, we cannot allow any extended family members. This rule will be strictly enforced. Memberships can be rendered null and void for providing false information according to Article VI, Section V of the Bylaws.

Pool Dues. Summer dues for 2020 are **\$425**. *Members who joined in 2019 on the "2-year plan" will pay \$625 (\$200 stock fee + \$425 current year dues) this year.* **Payments are due by April 15, 2020.** You can pay online with a credit card with a convenience fee added to your total OR you can print an invoice and mail a check to **PO Box 26089, Hoover, AL 35260-6089**. **Please do not mail anything to the physical pool address.** If your dues are received but postmarked April 15 – April 30, a late fee of \$25 will be automatically added. Any returned checks will be charged a \$35 fee. Unpaid memberships will be SOLD on MAY 1, 2020.

Selling your Membership? If you would like to sell your membership, send your signed stock certificate (or a letter in lieu of the certificate) to Shades Cliff Pool, Inc. to **PO Box 26089, Hoover, AL 35260-6089** before March 31st. If you have paid the stock fee portion of your membership, you will receive a \$200 check for the repurchase of your membership. Members may not sell memberships to anyone other than Shades Cliff Pool, Inc.

All Sundays and holidays (Memorial Day, Independence Day, and Labor Day) are members only days. No local guests are allowed on these days. A local guest is defined as anyone who lives in Jefferson or Shelby counties.

*Please be aware that on some Tuesday afternoons the pool will close at 3:00 PM for home swim meets. A schedule of meets will be posted on the bulletin board and website as soon as it is available.

In addition, pool hours will be reduced when school begins in August. Specific hours will be communicated later.

Swim Lessons. There will be two 1-week swim lesson sessions: June 8-12 in the morning and July 13-17 in the evening. Children must be pool members and at least 4 years old to participate in group swim lessons. Sign up for swim lessons will be announced.

All members, please be aware that the pool will open at 11:00 AM for the general membership when morning lessons are in session and will close at 6:00 PM for the general membership when evening lessons are in session.

Babysitters. Babysitters are non-members accompanying member children when parents are not present and must be at least 16 years old. A babysitter form must be completed in advance at the front desk of the pool AND signed by the parent. The fee for a babysitter is \$50 for the summer or \$10/week or \$5/day and can be paid at the front desk by cash or check.

General Information. The Rules and Regulations of the pool are posted on the Shades Cliff Pool website. Rules will also be available at the pool's front desk. It is our expectation of our members to follow all pool rules.
